#### 1. Introduction

The Legal Services Board of Nunavut (LSB) invites qualified vendors to submit proposals for the provision of SharePoint development services. The purpose of this RFP is to identify a vendor to design, configure, and implement a SharePoint Online solution that supports secure collaboration, document management, and workflow automation across LSB's offices and programs.

# 2. Organizational Background

The Legal Services Board of Nunavut provides legal aid services to residents of Nunavut in criminal, family, and civil matters. LSB operates in a unique northern environment, with staff and contractors located across multiple communities. Efficient and secure document management and communication tools are crucial for delivering services and ensuring compliance with privacy and legal obligations.

LSB currently uses a combination of shared drives and email to manage information. The organization seeks to implement SharePoint Online within Microsoft 365 to improve accessibility, collaboration, and version control, while ensuring data security and compliance with Canadian data residency requirements.

# 3. Scope of Work

The successful vendor will provide the following services:

- Assessment & Design Review current practices, recommend structure, and establish access controls.
- Development & Configuration Configure SharePoint Online, create sites and workflows, integrate with Microsoft 365 tools.
- Migration Plan and execute migration of existing data while maintaining integrity.
- Training & Support Deliver training sessions and documentation, and provide post-launch support.

Vendors may be required to sign a confidentiality and non-disclosure agreement prior to project commencement.

- Description of proposed approach and project plan.
- Estimated project timeline and milestones.
- Detailed pricing (including any travel or optional support costs).
- References for at least two similar projects.

#### 8. Evaluation Criteria

Proposals will be evaluated based on the following criteria:

- Relevant experience and qualifications 30%
- Quality and feasibility of proposed approach 30%
